| <b>Family Law Domestic Motions Dept 1C/1D:</b> LIMIT 16 - Confirmation required. All matters will be heard with oral argument unless noted by the Commissioner to be on pleadings. Proposed orders are to be submitted with working copies.  | <b>Protection Orders:</b> Parties should appear in person whenever possible. Working copies may be delivered at any time before the hearing but earlier submission will ensure they are received in time for the judicial officer to review them. | <b>Guardianship and Probate:</b> LIMIT 14 - All hearings related to adult guardianship cases will be heard on this calendar. For cases under RCW 11.130 Article 2, use the Minor Guardianship Calendar. All non-TEDRA probate motions will be heard on this calendar. |
| <b>GAL Compliance:</b> Matters assigned to calendar are court confirmed. Parties out of compliance with the requirements of the Supplemental Order Appointing must attend the hearing. Parties in compliance need not attend.  | <b>Temporary Restraint Denial Review:</b> Set by court only. Parties should appear in person whenever possible. Any amendments to petitions must be filed. Working copies must be submitted in advance of the hearing. No confirmations required. | <b>Civil Motions:</b> All matters will be heard with oral argument unless noted by the Commissioner to be heard by Zoom. Other restrictions apply to unlawful detainer motions and restoration of firearms. Confirmation still required.                              |
| <b>Pro Se Dissolutions:</b> Agreed matters and default orders only. Confirmation not required. Parties are currently required to appear in person unless granted permission to approve telephonically or via Zoom. In-person testimony required unless pre-approved by Commissioner. | <b>Ex Parte:</b> Entry of family law final orders require in-person testimony. Declarations in lieu of testimony cannot be used. Matters are heard on a first-come, first served basis.   | <b>Minor Guardianship:</b> LIMIT 8 - All hearings in regular and emergency minor guardianship cases will be heard on this calendar. Hearings require confirmation unless court confirmed.   |
|  | <b>Interpreter Calendars:</b> LIMIT 7 - Confirmations required except for protection order cases.   | <b>State Paternity:</b> Set only by the prosecutor.   |
