2. *RESERVATIONS*: The County of Snohomish reserves the right to accept or reject any and/or all bids and withdraw the property from the sale if it deems such action to be in the best interest of the County.

3. *PAYMENT*: Payment can be made by either cash or cashier’s check upon receiving notice of successful bid. If paying by cashier’s check, make payable to Snohomish County Treasurer. U.S. Funds only and no personal checks and/or bank cards accepted. Full payment must be made prior to removal of any bid items.
