**EDDS DEVIATION REQUEST FOR PROJECTS VESTED PRIOR TO 9-30-10**

**Note:** As of September 30, 2010 a fee of **\$1,390.50 per request**. (\$1,350 plus a 3% surcharge per SCC 30.86.030) will be charged for each deviation request. By this request the Applicant authorizes the County to delay processing the application being reviewed by PDS for up to 21 calendar days to allow for analysis and decision by the County Engineer.

**Instructions:** One deviation request per application.

Attach copies of the EDDS section(s) and/or standard drawings for which a deviation is requested. Include documentation such as drainage calculations, other engineering data and drawings, which will substantiate the request. Engineering details not meeting the required standards may require submittal by an engineer licensed in the State of Washington.

Please bring the complete application, all supporting documentation and the applicable fee to the submittal appointment at the Customer Service Center, R.J. **NOTE:** An EDDS deviation application is to be used **ONLY** when requesting to construct improvements to a different standard than that required by the EDDS. An EDDS deviation **SHALL NOT** be used to waive a requirement of SCC Chapters 30.24 (Roads and Access), 30.66B (Concurrency and Road Impact Mitigation) or EDDS Chapter 5 (Drainage).
