Purpose:

The purpose of this Pre-Application is to determine if a potential property may qualify for participation in the Savvy Septic Grant Program. This Pre-Application asks basic eligibility questions, and collects information that will be used to determine if the property falls within the Watershed Management Areas that grant funds must be spent within. If a property is found to meet basic eligibility criteria, an applicant will be contacted by Snohomish County Weatherization Services to complete the application process and income verification. Properties that do not qualify will receive written notice of their denial.
