

The MRC meets in Everett the third Wednesday of every month, from 6:30-8:30, with an additional 15 hours per month on project planning and implementation.

The [Snohomish County Sheriff's Office](#), Everett Police Department and SNOPAC have launched a new online tool for reporting crime. Designed to work on both home computers and mobile devices, www.mycrimereport.us may be especially useful for victims who need to report a crime for insurance purposes but are not able to wait for an officer or deputy to respond. The online tool generates a crime report number and sends that number to the victim's email within 72 hours. Minimum requirements: the victim must have an email address and know the location where the incident occurred. All reports are reviewed by law enforcement, and victims can request an in-person follow-up. The online tool is valuable for reporting minor crimes, such as vandalism, minor theft, and damage to and theft from a vehicle. Major crimes must still be reported to 9-1-1. These include felonies, theft or damage to items valued higher than \$5000, crimes in which the suspect is known, or crimes at an unknown address.

Feedback sought on Housing and Community Development Projects

There will be multiple opportunities for county residents to give feedback on how federal funding should benefit housing and community development. The programs provide funding that benefit low- and moderate-income people and neighborhoods in a diverse range of areas, including sidewalks, senior centers, housing for those with special needs, food banks, accessibility improvements, rental housing, and vouchers.

South County Cold Weather Shelter to Open

Beginning November 15, the South Snohomish County's Emergency Cold Weather Shelter will be open on nights when temperatures are anticipated to be 33 degrees or below. The shelter network is available to women, men and families who need overnight shelter. Meals are provided in the evening and the following morning. Whenever the shelter is activated, all persons should meet at one of two designated sites, **no later than 7pm**: outside [Lynnwood City Hall](#) or at the bus stop next to Trader Joes. Transportation to the shelter will be provided from these two locations.
