TEMP - PARK MAINTENANCE AIDE

BASIC FUNCTION

To perform a variety of routine maintenance and grounds keeping tasks.

STATEMENT OF ESSENTIAL JOB DUTIES

- Picks up litter on park grounds
- Collects and disposes of garbage
- Weeds flower beds and planters
- Prunes bushes and trees
- Trims and edges lawn areas
- Rakes leaves and clears debris
- Operates a push mower
- Operates a trimmer
- Operates a walk behind mid-mower
- Operates an edger
- Operates an infield groomer
- Operates a line striper
- Maintains mowing equipment
- Assists in aerating
- Assists in fertilizing
- May perform minor repairs to irrigation
- Sweeps and clears trails and walkways
- Washes trucks and other equipment
- Paints fences, garbage containers and other structures
- Operates a power washer
- Cleans gutters
- May assist Maintenance staff in performing maintenance duties
- Performs related duties as required
- Work is routine and spot checked for compliance by full time Maintenance staff

MINIMUM QUALIFICATIONS

Any equivalent combination of training and or experience that provides the required knowledge and abilities. Must be 16 years of age. Prior park experience and/or landscaping experience is preferred.

SPECIAL REQUIREMENTS

Must be 17 years of age to drive any Snohomish County vehicle within park boundaries. Must be 18 years of age to drive any vehicle outside park boundaries. All applicants are subject to criminal background check

WORKING CONDITIONS

The work is performed primarily outdoors in all types of weather at work sites throughout the county. The work may involve working at considerable heights, from ladders, hydraulic boom truck, or scaffolding. Employees are exposed to dust fumes, hazardous chemicals and inclement weather.

KNOWLEDGE AND ABILITIES

- Ability to lift 50 lbs.
- Ability to safely operate lawn mowers, trimmers, blowers and small hand tools
- Work in all weather conditions
- Work independently and in a group
- Perform manual labor involving frequent strenuous physical effort

PHYSICAL EFFORT

The work involves a variety of routine manual labor tasks requiring strenuous physical effort.

SUPERVISION

Employees in this class report to a Regular Park employee. The work is routine and recurring in nature and may be spot checked to ensure timely completion and compliance with instructions, procedures and standards. Specific instructions are given for unusual and non-routine tasks
