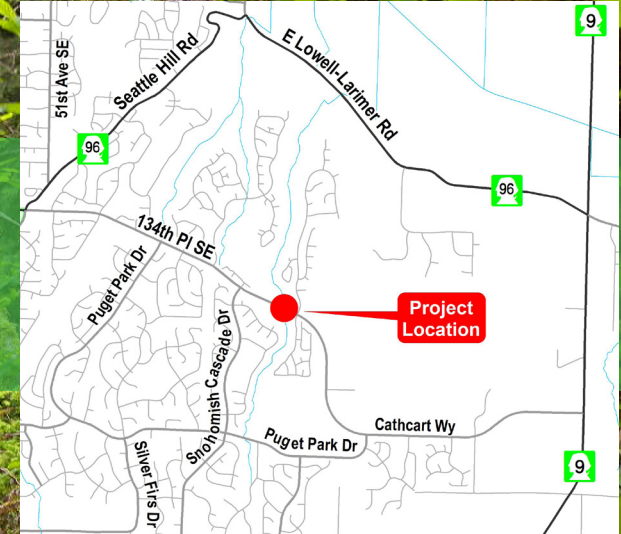


Notice of Land Disturbing Activity (LDA) Permit Application

Thomas Creek Bridge Flood Repair



Project Description:

Snohomish County Public Works proposes to repair the west embankment of the Thomas Creek Bridge (Bridge #642). The bridge embankment was damaged during the declared emergency flood event in February 2020 due to high flows in Thomas Creek.

The repair consists of replacing the toe of the west embankment with a rock buttress to strengthen the embankment and resist future scour. Additional work includes improving in-stream habitat with the addition of two large log structures and planting the site with native vegetation.

Project Location:

The Thomas Creek Bridge is located on Cathcart Way between Snohomish Cascade Drive and 69th Drive SE.

Project Construction:

The repair is planned to be constructed in late summer/fall and be completed by October 2020.

Grading Quantities:

Clearing: 2,500 square feet
Grading: 600 cubic yards
