Criminal Hearings are held in Courtroom 1A on the first floor of the County Courthouse. Criminal Motions are heard in Department 7/Courtroom 3E. The Civil Motions Calendar consists of adoptions, minor settlements, motions for commissioner's revisions, summary judgment motions and all other civil motions that are not to be brought before a Snohomish County Commissioner. Civil Motions are held in the individual departments of the hearing judge for that month. Adoption and minor settlements are held on Mondays from 9:00 AM to 12:00 PM only. Please contact the Civil Motions law clerk for that month to arrange either one of these. All other civil motions are heard Tuesday through Friday, 9:30 AM to 12:00 PM. Please confirm the Tuesday through Friday motions with the confirmation desk at 425-388-3587 pursuant to Snohomish County Local Rules.
