Family Law Domestic Motions Dept B/C: LIMIT 16 - Confirmation required. All matters will be heard without oral argument unless noted by the Commissioner to be heard by Zoom. Priority given for certain hearing types.

GAL Compliance: Beginning Feb 3rd, moves to 9:00 am 1st, 3rd and 5th Wednesday.

Domestic Violence: Zoom appearance encouraged, however in person appearance is allowed.

Interpreter Calendars: LIMIT 4- Confirmations required. Emergent contempt and custody matters only, Zoom appearance for these hearings.

Attorney Agreed Dissolutions: Confirmations required. Attorney involved default, agreed dissolutions, legal separations and invalidity actions. Written declarations should be submitted in lieu of testimony. Agreed orders must be received one business day prior.

Guardianship and Probate: LIMIT 14 - Matters will be heard without oral argument except petitions for new guardianships or hearings noted by the Commissioner to be heard by Zoom.

Minor Guardianship: LIMIT 8 Requires confirmation unless court confirmed.

Ex Parte: is open for emergency orders (see <https://snohomishcountywa.gov/5661/Ex-Parte> for more information). All non emergent orders should be delivered to the basket outside C-123.

Civil Motions: All matters will be heard without oral argument unless noted by the Commissioner to be heard by Zoom. Other restrictions apply to unlawful detainer motions and restoration of firearms. Confirmation still required.

State Paternity: Set only by the prosecutor. Will be heard by Zoom. *Only heard the 2nd and 4th Wednesday of the month

Special Sets: Set by Commissioner only
