**1 Offender Docket and Motions.:** Probable Cause Hearings, Warrant hearings, Show Cause Hearings (Tuesday-Thursday), Diversion Termination Hearings, Revocation Hearings, Truancy and ARY Warrants on Tuesday, Wednesday and Friday, In Custody motions.

**2 Pleas:** Plea and Sentencings should be set to this session. When the session is full or if the plea will be lengthy or has multiple cases, these may be set to a Judges Special Set session.

**3 Fact Findings:** Offender Fact Findings may continue into the afternoon if not completed in the morning session. Any Fact Finding longer than 2 hours will be scheduled at Superior Court.

**4 Arraignments:** Offender youth are arraigned in this session.

**5 Confirmations:** Trial readiness is heard in this session. If a holiday falls on a Thursday, the Confirmations are moved to Wednesdays at 9:00 am.

**6 SAU:** All cases with a sex offense will be heard in this session.

**7 Sealing:** Motions to Seal, Administrative Sealing. Heard the 1<sup>st</sup> and 3<sup>rd</sup> Thursday of each month-offender judge.

**8 Judges Special Set:** Special Set through Judge's law clerk only-Judges may use this an overflow session, special cases, motions on shortened time or motions needing to be heard when the judge is in the opposite rotation. **Does not occur on Thursdays with Bi-Monthly FTA Calendar**

**9 Dep Shelter Care:** Heard in the Offender Court room Mon-Thurs, in the Dependency courtroom on Fridays. This is the 72-hour hearing post children being removed from their home or a dependency petition having been filed.

**10 Non-Contested Adoption Reviews:** In chambers review of dependency cases for children that are legally free. **These cases are heard by Judge Appel in Dept 1 at Superior Court.**

**11 Termination Preliminary:** Preliminary hearings for termination cases heard here.

**12 UFC Preliminary:** Cases are reviewed for the need of a family law action prior to the dismissal of the dependency. Cases should be set here when a child has been returned to one parent. A proposed order making a recommendation for family law action will be circulated prior to the hearing. Any party wishing to contest the recommendation will respond and the hearing will be heard. If not contested, the order will enter ex parte.

- 13 UFC: Unified Family Court Hearings:** Family law motions to be heard by the dependency judge for families in dependency cases.
- 14 Motions w/o Oral Argument:** Dependency motions to be heard without oral argument, unless a party objects.
- 15 Contested Motions:** Contested Dependency motions to be heard in these sessions. Court dates need to be obtained from the clerk's office
- 16 30-day Shelter Care Review:** Reviews set to this calendar are reviewed in chambers. Shelter care reviews hearings maybe set for live review to any session as allowed by the judge.
- 17 Dependency Publication/Default Preliminary:** Dependency and Termination preliminary hearings that are served by publication or motions for default are set to this session.
- 18 Preliminary Hearings:** Dependency preliminary hearings heard in this session.
- 19 Review Hearings:** All Initial progress reviews (6-month reviews), Permanency Planning Reviews, Dependency Review (15 month) and other review hearings are scheduled to this session. Judges may use special set sessions for overflow.
- 20 Dependency Fact Finding Call:** Dependency Fact Findings that are shorter than a half day are set to this session (longer FF are scheduled on the Superior Court Trial schedule). Cases that move forward will be heard that afternoon.
- 21 Adoption Reviews:** Dependency cases with a legally free child will have reviews in this session. ***These cases are heard by Judge Appel in Dept 1 at Superior Court.***
- 22 Permanency Planning, Legally Free:** Dependency cases with a legally free child will have Permanency Planning hearings heard in this session. ***These cases are heard at Superior Court.***
- 23 Bi-Monthly FTA Calendar –** Heard on the 1<sup>st</sup> Thursday of every odd numbered month pursuant to JuCR 7.16.
- 24 Truancy:** All truancy matters will be heard in these sessions.
- 25 Emancipation:** Emancipation hearings are heard the 2<sup>nd</sup> Monday of every month.
- 26 CHINS/ARY:** Hearings set through Probation CHINS/ARY department.
- 27 Adult Family Drug Court.** Heard by Judge Larsen @ DJJC during her rotation.
