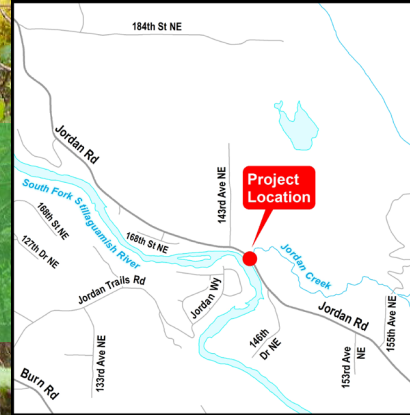


Notice of Land Disturbing Activity (LDA) Permit Application Jordan Creek Bridge 214 Replacement



Project Description:

Snohomish County Public Works proposes to replace Jordan Creek Bridge 214 at its crossing of Jordan Creek on Jordan Road. The existing bridge is a two-lane 21-foot wide and approximately 107-foot long timber trestle bridge supported by creosote-treated timber piles with a timber deck. The bridge is functionally obsolete and structurally deficient and is currently load limited and reduced to one 16-foot lane.

The proposed replacement bridge would be a single span buried concrete arch bridge supported on spread footings with shallow foundations. The bridge will have two 11-foot travel lanes and 6-foot shoulders. This design will allow the bridge span to be shortened from 107 feet to approximately 60 feet. A temporary detour bridge adjacent to the existing bridge or a full road clo-

sure during construction are being considered. The project is scheduled for construction in summer of 2024.

Location:

Jordan Creek Bridge is located on Jordan Road between 143rd Ave NE and the 155th Ave NE, southeast of the City of Arlington, in Section 2, Township 31 North, Range 6 East.

Area to be cleared or grubbed: 2.6 acres
Amount of cut: 2900 cubic yards
Amount of fill: 4900 cubic yards
