1 Out of Custody Arraignments (limit 15): Arraignments of out of custody defendants

2 Criminal Hearings (limit 8): Hearings lasting less than 10 minutes, including: trial settings/continuances, waivers of jury trial, motions for stays, and motions to review, reduce, increase or revoke bail or personal recognizance, CSV, weapons surrender review, quash warrant, TAP review, competency/capacity review

3 Video Calendar: Video hearings involving defendants in custody at Snohomish County Jail including arraignments, fugitive matters, and short competency evaluation, restoration, or review hearings.

4 Plea/Sentencing (limit 15): Calendar for hearing pleas only, agreed sentencings (no victim), and agreed plea and sentencings (no victim)

5 Post-Conviction Motions: Calendar for post-conviction and legal financial obligation (LFO) motions; motions on this calendar are without oral argument

6 Plea Calendar (limit 15): Plea only calendar, where sentencings will be set for future dates

7 Trial Calendar: Criminal Jury Trials

8 Extended Criminal Motion: Hearings lasting longer than 10 minutes, including: 3.5/3.6 Suppression, Arraignment on Amended Information, Continuances, Motions, etc. Hearings will be held in courtroom of the judge assigned to the rotation. Judge's courtroom information can be found on the 2022 Criminal Hearings, Criminal Motions, and Civil Motions Calendar (2022) posted at <https://www.snohomishcountywa.gov/1338/Calendars-and-Schedules>.

9 Omnibus (limit 30/30): Omnibus hearings. Agreed omnibus orders are reviewed in chambers prior to 9:00am. Contested omnibus hearings are heard at 9:00am and 10:45am Wednesday and Thursday and 1:00 pm and 2:45 pm on Friday. Wednesday and Friday calendars are to be used for first or second Omnibus hearings; Thursday calendars are to be used for first Omnibus hearings *only*.

10 Criminal Motions Call: Extended Criminal Motions being heard the week following the calendar are to be confirmed via e-mail by 12:00pm Friday. Parties are not to appear in person for this calendar unless there is an issue or other emergency preventing e-mail confirmation.

➤ **Please Note:** If a holiday falls on a Friday, the schedule for the last court day of that week will be the Friday schedule. Thanksgiving holiday is observed on a Thursday and Friday, so Wednesday becomes the Friday schedule.
