



Welcome to Kayak Point County Park!

In 1967, the land this 670 acre park sits upon was destined to become an oil refinery. But in 1972, Snohomish County, with assistance from the Inter-agency Committee for Outdoor Recreation, purchased

the land from the Richfield Oil Corporation. Today, Kayak Point is Snohomish County's most popular park where visitors enjoy the wooded forest and over 3,000 feet of Port Susan (Puget Sound) shoreline. Fish and crab from a 300' fishing pier, host parties and events under 12 picnic shelters, fly a kite in the open fields, hang-out in

RULES

Okay, every park has them, so let's get it over with. To maximize your enjoyment, take a few moments to review some important rules.

Day-use

- Park hours are 7 AM—Dusk
- Alcoholic beverages, fireworks, and discharging of firearms are strictly prohibited
- No hibachis and/or barbecues on table tops
- Use of drones is prohibited
- All vehicles must display a valid parking permit

Pets:

- On an 8' leash, and under control at all times.
- Pets must be attended at all times
- No pets in the Yurt Village
- Remember to scoop! Remove all your dog's feces. The shoe you save may be your own

Motor Vehicles:

- Speed limit is 10 mph unless otherwise posted
- Bicycles, scooters, and skateboards are allowed on the roadway and must travel in the same direction as motor vehicles

Noise:

- For the enjoyment of all park visitors, loud speakers, stereo systems, and vuvuzelas are prohibited
- Campground quiet hours are 10 PM— 8 AM

Camping:

- All campsites, yurts, cottage, and shelters can be reserved at www.SnoCoParks.org. Unreserved sites can be rented on a walk-in basis
- Walk-in payments are made by completing a fee envelop and dropping in the fee box located at the campground bulletin board (kiosk).
- If a motor home or truck/camper setup needs to temporarily leave the site, please make arrangements with the ranger to secure the site.
- Firewood sales are available during daylight hrs
- Campground stays are limited to no more than 14 consecutive days

CAMPSITES

The Kayak Point Park campground is comprised of 32 wooded, private sites. Premium sites are large and/or offer partial bay views. The paved ADA sites are conveniently located close to the restroom and shower facility. All sites have power. Starting Summer 2017 all sites will have water.



WATER TRAILS

Kayak Point Park has designated beach campsites for Water Trail camping. Fees are on a per-boat basis and space is limited to 3-4 tents. To be eligible, campers must arrive and depart by human or wind powered beach able watercraft. Visitors to sites that enter the park by other means must exit the park by dusk.

YURTS



Leave the RV and tents at home! On your next camping adventure, stay in one of our 10 Yurts. Enjoy hardwood floors, screened windows, locking door, lights, electricity, and wall heater to keep you cozy warm and dry (which is really something in the Northwest)! Each Yurt sleeps 5 and has its own picnic table and fire pit for after dark marshmallow roasts. Be sure to bring sleeping bags/bedding and your other usual gear. A village picnic shelter for Yurt guests is exclusively yours for outdoor cooking, dining, and gatherings. By reservation only-sorry, we cannot accept drop-in yurt camping.

Our 10 beachfront North shelters contain 2 picnic tables, BBQ grill, and nearby water faucets. They can accommodate up to 25 guests. The Kite shelter is conveniently located next to the playground and restrooms. The South shelter is great for large events which can accommodate up to 150 guests. It has power, water, restrooms, and BBQ grills.

KAYAK KOTTAGE
